All Special Education majors dual-major in Early Childhood Education.

All certification candidates are required to take a minimum of 9 credits of special education plus complete a minimum of 190 hours of field work. The IEP document itself is reviewed in all of the special education courses that are a part of the 9credits of required special education content. These include simulations, role play, and written assignments.

The field experience opportunities are varied to enable students to observe and participate in a variety of special education placements.

Students majoring in special education take 30 credits of special education content.
