Biographical / Historical

Thomas W. Corbett, Jr. (b. June 17, 1949), received his undergraduate degree from Lebanon Valley College (Class of 1971) and his law degree from St. Mary's University of Law (1975). While pursuing his educational degrees, he served in the Pennsylvania Army National Guard from 1971-1984, rising to the rank of captain. After several years of private law practice, during which time he also served as commissioner of the Pittsburgh suburb of Shaler Township, President George H.W. Bush appointed him to serve as U.S. Attorney for the Western District of Pennsylvania (1989-1993). In the 1990s, Corbett served as a special advisor to Pennsylvania Governor Tom Ridge and was also appointed chair of the Pennsylvania Commission on Crime and Delinquency (PCCD), where he shaped criminal justice policy and worked to improve drug and alcohol prevention and rehabilitation programs across the state. In 1995, Corbett was appointed by Ridge to fill out the remainder of the unexpired term of Attorney General Ernie Preate, conditional upon his pledge not to seek re-election in 1996. After leaving office in 1997, Corbett returned to private practice, and in 2004 and 2008, was re-elected as state attorney general. In 2010, while serving out his second term as state attorney general, Corbett won election as the 46th Governor of Pennsylvania, serving from 2011-2015.
